FAQs When are transactions processed?

Withdrawals from your bank account takes place on the 20^{th} of the month (or the next business day if the 20^{th} falls on a weekend). You must notify your church of any changes to your account or donation amounts by the 10^{th} of the month.

How does my church know what I have given?

The church will be receiving a monthly offering report.

Who issues tax receipts?

The church is responsible for tax receipts.
